SUPERVISOR DWYER- Thank you. At this time, we've received no written comments from anyone. Do we have anyone in the public that would like to offer any Community Development Block Grant Program projects? So, it looks like that's not the reason everyone is here. The Town Board does have a proposed project that we would like to submit for Community Development Block Grant funding and that is a \$275,000 project to rehabilitate the bathrooms at the Mountain Lake Park Pickleball Courts. The facility does have an old bathroom house and snack stand on the property and we would like to apply to the Community Development Block Grant Program for new ADA accessible bathrooms as well as a first aid stand at the Mountain Lake Park Pickleball and Pool Facility. Any comments from the board? Any comments from the public on our proposed submission to the Block Grant Program? There being none, I make a motion that we close the public hearing.

PLEASE TAKE NOTICE that the Town Board of the Town of Warwick does hereby set a public hearing on May 14, 2026 at 7:00pm or soon thereafter as the matter may be heard at the Town Hall, 132 Kings Highway, Warwick, New York on proposed Application for FY-2027 Orange County Community Block Grant Program. The Town of Warwick invites public comments and suggestions regarding projects to be considered for funding under the Orange County Community Development Block Grant Program. Under this Program a variety of physical improvements as listed below are eligible for funding: acquisition and disposition of real property; public works, public facilities or site improvements; code enforcement (housing and health codes); clearance, demolition and rehabilitation for public use or economic development; housing rehabilitation loan and grants; special projects for elderly and handicapped; provision of public services (shelter, clinics, senior nutrition, etc); payment of non-federal shares of other grant programs; relocation payments and assistance. The Town of Warwick will be considering projects to be submitted to the Orange County Development Block Grant Program. The deadline for submittal is June 12, 2026 at 4:00pm.

All interested persons will be given the opportunity to be heard. All written comments must be received by the Board at or prior to the public hearing.
