Name of Action: Blain Town Square

**Whereas**, the Town of Warwick Planning Board is in receipt of an application for site plan approval on Town of Warwick tax lot SBL 51-1-41.2 on NYS Route 94 North. The project site is within the Community Business (CB) zoning district, and the Ridgeline Overlay, Aquifer Protection Overlay, and Agricultural Protection Overlay districts. The applicant is proposing a mixed-use commercial/residential/recreational development on approximately 38 acres of land fronting on the northbound side of NYS Route 94, across from the Price Chopper entrance. The project includes eight proposed structures having a total footprint of 145,200 square feet and will be a mix of office, retail, food service, and other uses. Four of the structures will each have 18 one-bedroom accessory apartments on the second story. A ninth building and associated athletic field is also proposed to be used for indoor and outdoor sports and recreation. Additional improvements proposed include access roads, parking, utilities, and stormwater management facilities; and

**Whereas**, a Full Environmental Assessment Form (FEAF) was submitted by the project sponsor, dated June 24, 2025; and

**Whereas**, after comparing the application to the thresholds contained in 6 NYCRR 617.4 and 5, the Planning Board has determined that the proposed project is a Type I Action, as the project will involve the physical alteration of over 10 acres; and

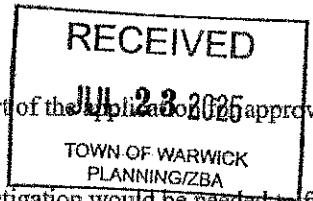

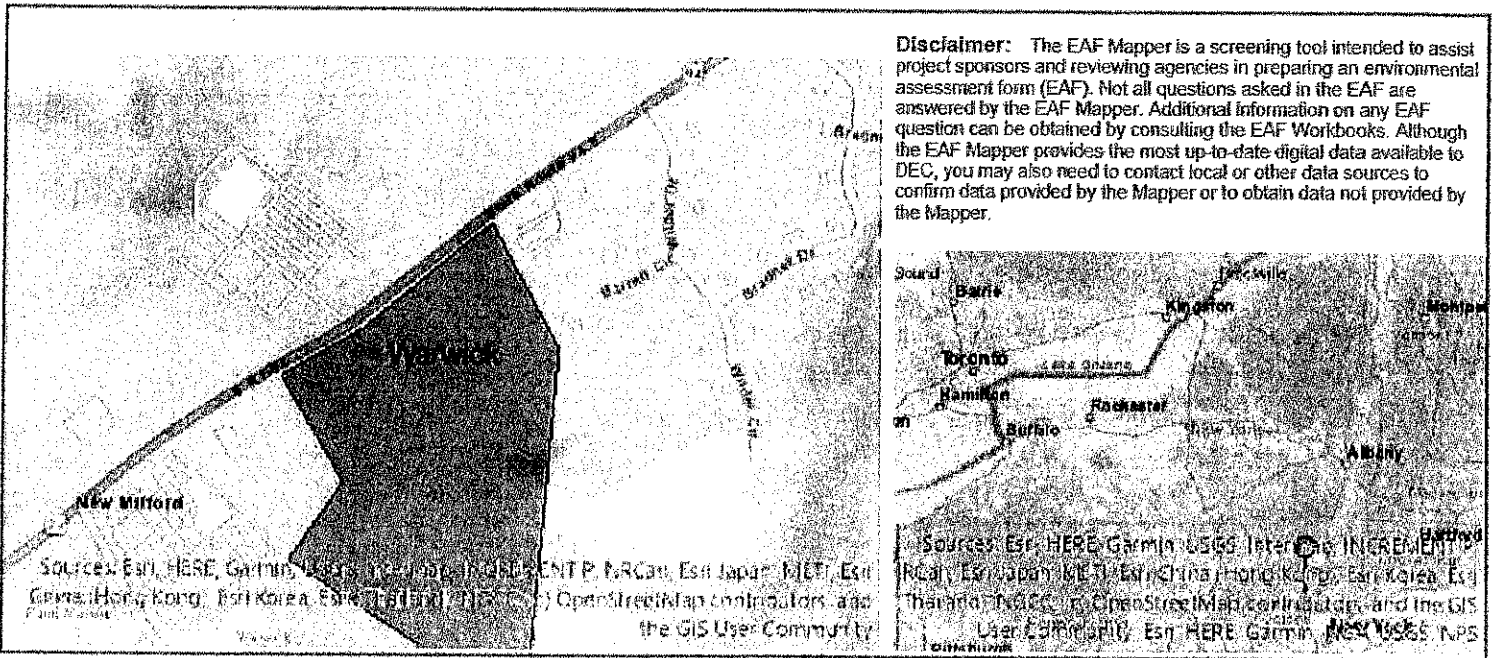
