

Supervisor Dwyer – This time we are not going to open up the general meeting. We are going to open up a public hearing on Introductory Local Law #7 of 2024 to exceed the 2% tax cap. This is a typical procedure that is done every year since the introduction of the tax cap. As we are in the process of developing our budget certain emergencies could come up that come near the deadline to submit your final budget and if you do not introduce this local law then you will be subject to penalties if you happen to override the tax cap, which is 2% this year. We are early in the budget process. This does not necessarily mean that the Town Board intends to exceed the 2% tax cap. It will just give us the statutory ability to do that if needed. Any comments from the board before we go to the public? Any comments or questions from the public on this local law? Any comments from the staff of the Town of Warwick on this local law?

There were no public comments for or against this public hearing from the public or Town Board.
