

**SUPERVISOR DWYER** – At this time, we'll go into a public hearing on Introductory Local Law No. 8 of 2024, amending Chapter 112, Peddling and Soliciting. The intent behind this local law is to change our town code. We identified that our code did not necessarily prohibit people from operating commercial businesses on town property, so Attorney Buckheit has presented the Town Board with a suggested code change that will now require, which you thought would have been obvious, that if someone intends to conduct commercial operations on any town property, including town parks, they will require written permission from the Town Board. In order to do that, the Deputy Clerk will read the notice. Any questions or comments from the board? Any questions or comments from the public on this local law?
