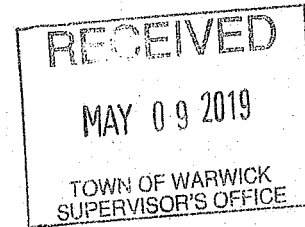

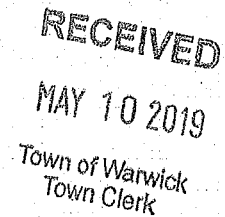


Dear Supervisor Sweeton and Town Board Members:

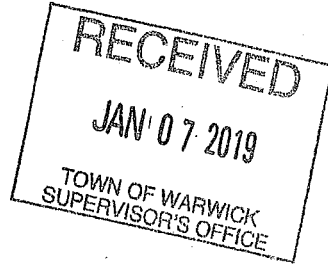

Dear Mr. Sweeton and the Town of Warwick Board:

On behalf of the family of Riley Mosher, I would like to take this opportunity to thank Officer Brett Lukach, Sgt. Morley, New York State Trooper Russell Fragale, and EMT Bobby Lemin for their outstanding acts of kindness, professional and collaboration on December 21, 2018.


On the morning of December 21, 2018 every parent/grandparent's worst nightmare came true when we found our beloved Riley unresponsive. A frantic call was made to 911 while CPR was started. Officer Lukach responded in less than 2 minutes of the call. A split-second decision was made to transport via the squad car while CPR was administered by the Bobby Lemin, as Trooper Fragale escorted the car.

Arriving at the hospital we were greeted by Sgt. Morley, along with Officer Lukach, Trooper Fragale and Mr. Lemin. It was a desperately frantic situation as doctors and nurse worked feverishly and frantically to save Riley. The officers from the Warwick Police Department gave us strength, held us while we cried and prayed with us as we begged for a miracle.

When the decision was made to transfer to Westchester Medical, Sergeant Morley coordinated with other local authorities to make sure our trip was without obstacle. Trooper Fragale and Officer Lukach made it possible for us to arrive at Westchester Medical Center safely during a heavy rain storm, something we are quite certain we would not have been able to do if it weren't for them going above and beyond normal expectations or requirements.

Unfortunately, though our sweet Riley did not survive Sergeant Morley, Officer Lukach, Trooper Fragale and Bobby Lemin should be recognized for their outstanding acts performed in the line of duty. It is officers like these that will do anything to protect and serve their community. They give up holidays, birthdays and family gatherings, putting the community they serve first. Most importantly, they should be recognized and thanked for a job most of us couldn't do. It takes a strong and brave person to deal with the things they do on a daily basis and do them well day after day.

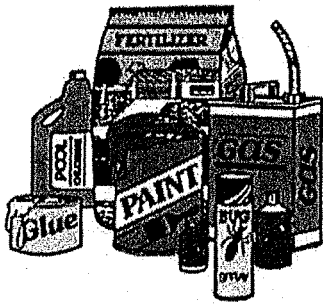

Acceptable Items: Adhesives, Aerosol Cans, Automotive Products, Fire Extinguishers, Flammable Liquids (oil, gas, kerosene and/or mixtures), Corrosives/Cleaners, Creosote, Driveway Sealer, Pool Chemicals, Fluorescent Tubes, Inks, Mercury, **Oil Based Paints Only**, Pesticides/Herbicides, Propane Cylinders (camp size), Roofing Tar, Rubber Cement, Solvents/Thinners, Varnishes/Shellac/Stains, Wood Preservatives, Car Batteries, Zinc-air & Lithium Hearing Aid Batteries.

NOT Accepted: Refrigerators, Tires, Air Conditioners, Electronics, **Latex (water based) Paint** (see how to dispose of Latex Paint below), BBQ size Propane Tanks, Appliances, Single-Use Batteries (can be thrown in the household trash).

How to Dispose of Latex Paint: Remove the lid, put the paint can in a safe place away from children and animals and let the paint dry out. If there is a large quantity of paint in the can, line a cardboard box with a black garbage bag, pour the paint in the garbage bag and add cheap, clay kitty litter until the paint is solid. 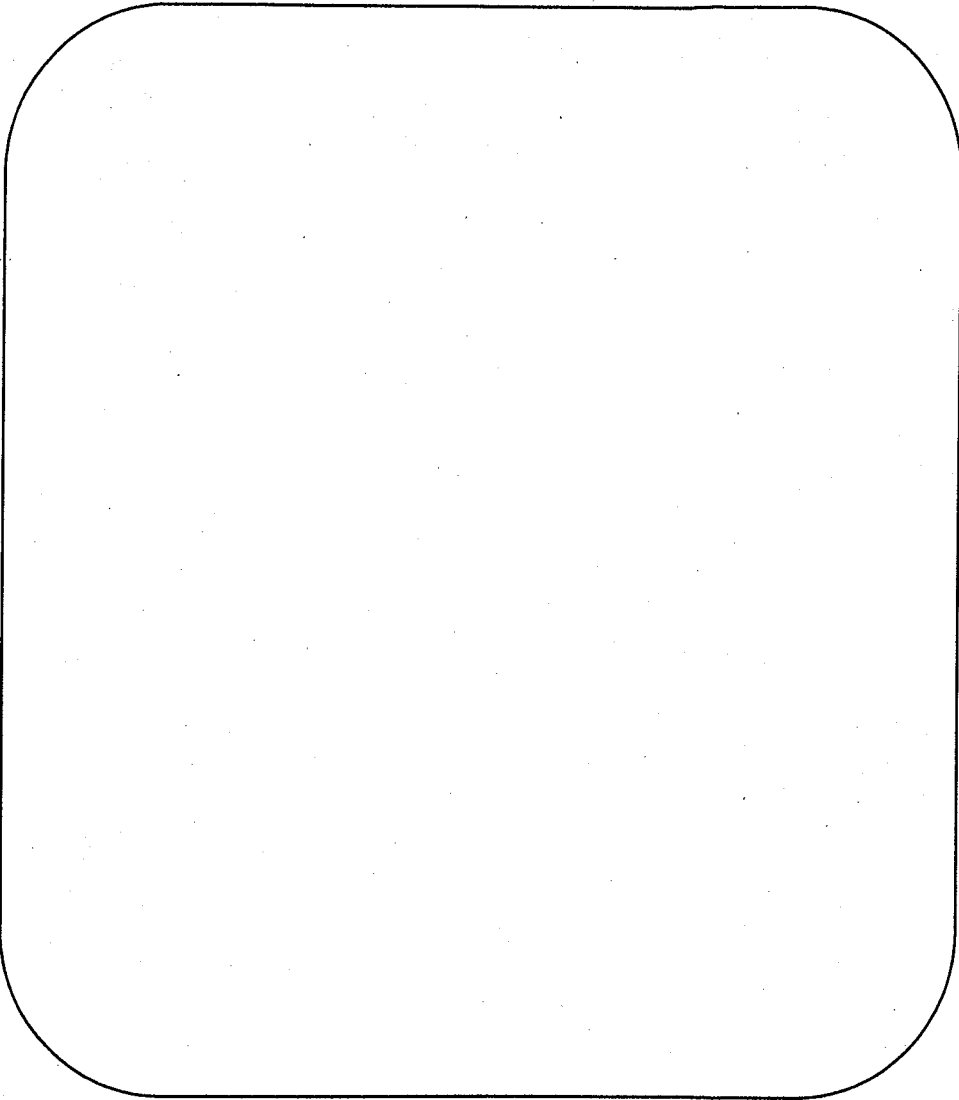

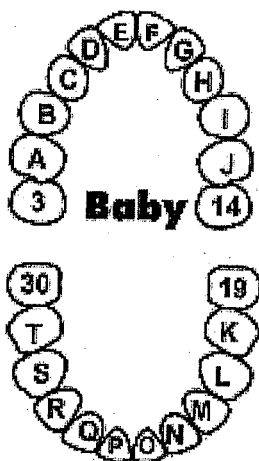

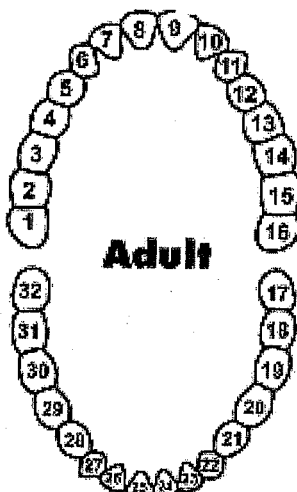

500,000 children a year are reported missing in the United States and Canada, these statistics are horrifying, but an identification booklet will provide you a peace of mind and measure of extra security where every second counts.

Let's keep our children safe and talk about the safety tips below with them.

1. Do not walk away with anyone other than a parent or arranged family member.
2. Avoid getting into cars with strangers at all costs.
3. Remember, an adult will not need help from a child, do not listen to "I need help finding my kitten."
4. Know your name, phone number, and address.
5. If your child wanders off at the store, instruct them to go to the counter and announce they cannot find you. They should remain there until you locate them. Do not wander off.
6. Explain to them that no one is allowed to touch their body except for mommy and daddy if needed.
7. Always try to walk to and from school in groups.
8. Never post any of your personal contact information on social media networking sites.
9. Check with your parents before posting any pictures online.
10. Take interest in the internet sites your child visits and monitor their computer usage.

IF YOUR CHILD IS MISSING:

Contact police immediately, share a description of what they were wearing the day they went missing and provide the Child Identification Booklet. Request that your child's name be entered into the National Crime Information Center Missing Person File (NCIC), which allows any law enforcement agency in the U.S. to identify them.

The photo in this booklet should be updated every 6 months to a year. We hope that there is never a need to use this booklet with law enforcement, but in the sad event you may, every second counts and all the information contained in this booklet will increase your chances of recovering your child.



Orange & Rockland has been delivering natural gas service to its customers reliably and efficiently for over 75 years through an extensive underground network of transmission, distribution and service pipes that is virtually unparalleled as a safe and secure method of transporting energy.

Through 1,842 miles of pipeline, O&R serves more than 133,000 natural gas customers in New York. We work closely with government regulators and industry organizations to make sure that we operate our pipeline system as safely and as responsibly as possible according to federal, state and local regulations.

I am writing to you today as part of our overall public awareness efforts, and as required by the Pipeline Safety Improvement Act of 2002 and the resulting amendments to the Code of Federal Regulations enacted in 2005. I have enclosed a brochure that provides an overview on our natural gas safety program and a guide for recognizing and responding to pipeline emergencies.

You should know that the greatest risk to underground natural gas pipelines is accidental damage during excavation work. That's why we frequently remind everyone from contractors to landscapers to highway departments to weekend gardeners to "Call Before You Dig" so that the location of all underground utilities can be marked before excavation begins to prevent injury and damage. It's a simple call to 811, two to 10 days prior to ANY digging activities. Should you smell gas or suspect a gas leak, call our Gas Emergency Hotline at **1-800-533-5325**.

It is also important to note that while most of our underground pipelines run along a public street, some may also pass through backyards and open fields. The building of swimming pools, fences and other encroachments upon these pipeline rights-of-way can inhibit our ability to respond to emergencies on the pipeline, eliminate third-party damage, provide surveillance, perform routine maintenance, and perform required federal and state inspections. For everyone's safety, rights-of-way locations must be respected.

Our commitment to safety

Safety is the natural gas industry's top priority. Nationwide, more than two million miles of pipelines and mains deliver natural gas safely, reliably, and efficiently every day for use by residential, commercial and industrial customers. The industry spends more than \$6 billion each year to maintain the gas system's excellent safety record. We will continue to invest in programs that allow for the safe and secure delivery of natural gas, and to work closely with industry and government on a variety of important measures, including:

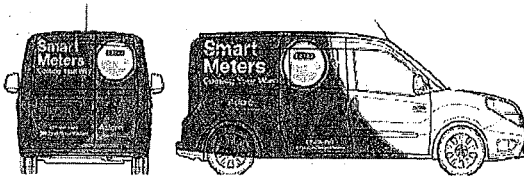

What's a smart meter?

It's a digital meter that communicates between your residence or business and Orange & Rockland through a secure wireless communication network.

What's the difference between my current meter and a smart meter?

They both do the same job: They collect information about how much energy you use. While we can only collect your usage information from your current meter once a month, a smart meter sends readings every day, using the same type of extremely low-frequency radio signals that allow you to use your smartphone, listen to the radio, or watch TV. Smart meters will also let us know right away when problems arise, so we can get to work on restoring power even faster.

How will a smart meter help me?

Your smart meter will let you keep track of how you are using energy and help you manage your bill.

Once your smart meter is installed, you'll have online access to detailed information about your daily energy use. You can use that information to make choices that can help you save energy and money.

- See your energy usage in 15-minute increments.
- Get high-bill alerts (and tips on how to avoid them).
- Get information about energy-saving products and services.

Smart meters will allow us to read your meter remotely. That means no more waiting for a meter reader, and no more estimated bills. We will also be able to activate service remotely.

If you use solar energy, a smart meter will help us integrate these renewable resources more efficiently.

When will I get my new meter?

Installation will begin in Rockland County during the summer of 2017. O&R plans to install smart meters throughout its entire service territory by 2020. O&R will notify you with a postcard and a letter before installation starts in your area. If you need to be home for us to access your meter, we'll let you know how to set up an appointment. Installation takes only about 15 minutes.

Will my power be interrupted while you install my new meter?

Yes, there will be a brief pause in your electric service (a couple of minutes at most). For many commercial customers, we may be able to avoid a service interruption. We will leave you a reminder to reset your clocks and other appliances, and we apologize for this inconvenience.

Will I need to do anything to start my meter?

Nope, we'll handle everything for you. But we'll be providing you with instructions on how to access and make the best use of information from your smart meter.

How are you protecting my privacy?

We take cyber security seriously, so all information is transmitted through an encrypted network. No personal information is captured or transmitted by the smart meter, and all your energy usage information is kept confidential by O&R and our vendors.

Do I still need to call O&R to report an outage?

Yes. Smart meters will alert us about most outages in your neighborhood. But we suggest you continue to tell us about any problems you are having so that we can address them as quickly as possible.

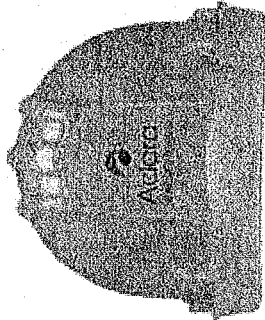

This notification is part of the NYSPSC approved customer outreach and education plan for Orange & Rockland.

Customers receive several notifications prior to installation including: a postcard 90 days prior; a detailed letter 45 days prior; and a reminder telephone call 10 days prior to installation. For your convenience, I have attached the following documents should you receive any inquiries.

- O&R Smart Meter Contractor Identification Information
- Smart Meter FAQ Sheet
- Post Card sent to each customer.

O&R has engaged **Aclara** to perform the Smart Meter installations. All contractor employees carry a contractor badge and wear a bright yellow vest and helmet that reads Aclara. Additionally, the contractor's vehicles are wrapped in orange with O&R's logo, Aclara's logo and the slogan "**Smart Meters Coming Your Way**".



As the Smart Meter deployment progresses, additional notifications for other routes in your community will be provided on a monthly basis.

spent \$20 on a lamp from China, it would tip over, and I'd have to buy a new one. Thanks, you've made my day!"

Steve and Fred sharpened knives, clippers, trimmers, scissors, shears, and a wire cutter. Scott, who repairs fretted instruments, such as guitars, when his schedule permits, brought along a student musician and they both entertained us with a guitar concert. Payton hosted a table with samples of "go green" toiletries and personal care items. Bette, who also volunteers to sort items donated to the Hope Chest, displayed quilts, pillows, and other items that she sews with discarded T shirts and other textiles.

Rob diagnosed problems for people who brought in damaged digital devices. His teenage daughter, whose school requires community service hours for graduation, volunteered alongside him with two boys who came to watch and learn. The teens pitched in to help pack up volunteer's supplies at the end of the day.

Joan, Deanne, and Raheli stitched a pair of red, white, and black leopard print gloves, somethings described simply as "sewing," pants "zipper," "button hole on jeans," a hat and a curtain that "need sewing," sock "stitch the toe," tote bag "ripped seam," coat "alteration," and something with a broken zipper. Barb labored all alone on baubles, bangles, beads, multiple bracelets, watches, and a necklace.

Only 11 items were found to be un-fixable. Of those, most needed specific factory parts, including fuses, power cords, and watch batteries that we can't stock. One lamp ticket read, "needs to return, not enough time for diagnosis and repair." **Only 4 items were deemed beyond repair.** The owners are often relieved to learn that their item really is, as one person described it, "Done and dead; now I can dump it." But we always ask them to donate the item to the Kids Take It Apart Table capably and imaginatively hosted by Jim H.

The trouble with dumping things is, as Ermin Siljkovic, Recycling Coordinator Orange County DPW, said at our last Sustainable Warwick meeting, "There is no away." As part of his power point presentation, "Waste Prevention Reuse & Recycling in Orange County," Ermin highlighted the Repair Café, Too Good To Toss and the Recyclopedia in his presentation under "Other Waste Prevention Reuse & Repair Links."

Barry Cheney invited me to call in to the WTBC's legislators' radio program, last week, to talk about the upcoming Repair Café and provide a brief TGTT recap. After co-chair, Payton Swenson, and I talked about TGTT (we admitted 387 people onto the basketball court in the first hour and a half and were open for another three and half hours in pouring rain), Barry said that our free community swap "Adds value to the Village. .. minimizes what the DPW has to pick up," and that "the Village would have to fill a lot more dumpsters without TGTT."

So, once again, thanks for supporting the Repair Café and Too Good To Toss. You are helping to provide places and events where the public can repair or donate useful items, rather than burden the DPW with finding an affordable and appropriate way to dispose of useful things.
