CORRESPONDENCE:

DOREEN DONNELLY - Senior Account Clerk, Town of Warwick. Memo to the Supervisor dated December 8, 2021 regarding the Unpaid Water Re-levy.

Supervisor Sweeton – The Purpose of the meeting is from Doreen Donnelly our Senior Account Clerk a memo regarding unpaid water re-levy's. For the public's information the reason we needed to do this is because back in the beginning of the year the State Legislature passed a law saying for 180 days or through December 31st a municipality could not cut anyone's water supply off if they were affected by Covid financially and you had to offer them time and you could not place a lien on the property. Normally there are some people who don't pay their charges and it gets re-levied on their taxes and they pay that in January. The County determined that a re-levy was a lien therefore we couldn't do it unless we put the residents on notice and we had to give them 30 days. We did do that and the 30 days is now up and we got just a handful of respondents and now we are able to re-levy the charges from those who did not respond and we can be in compliance with the legislation that was passed and signed by the Governor. That is why we are here today and we will move into new business.

#R2021-308 APPOINT PART-TIME SEASONAL DPW LABORER – MICHAEL J. GILMARTIN


